# CAMWS 2002 Convention in Austin TX

The 2002 Annual Meeting of the Classical Association of the Middle West and South will be held in Austin, Texas from Wednesday, April 3 through Saturday, April 6 at the Austin Marriott at the Capitol Hotel at the invitation of the Department of Classics of the University of Texas at Austin. All convention sessions will be held at the Austin Marriott at the Capitol Hotel except for Friday afternoon sessions at the University of Texas at Austin School of Law in Townes Hall and a reception next door at the Texas Memorial Museum.

HIGHLIGHTS OF THE PROGRAM: This year's program includes several panels of special scholarly interest on: Recognition, Subjectivity and Gender in Roman Poetry; The Animal Life of the Greek Polis; Neoi: The Education of Youth in Antiquity; Mystery and History; Classical Film Philology: Gladiator as Visual Text and Intertext; and On to 10,000: The Inexorable March of the Suda On Line. There are a number of special panels on **pedagogical** subjects: Helping Marcus Read: Some Approaches Toward Bridging the Transition from Elementary Latin to Reading Roman Authors; Greek and Latin Alive! A Tribute to Gareth Morgan; Linking Latin in the Curriculum Beyond the Latin Classroom; Aegyptus Capta: Taking Greco-Roman Egypt into the Classics Classroom; and The 2002 National Latin Exam and New Approaches for NLE's Forum Romanum.

Some special events **special events** will be tributes to Clarence Forbes and Gareth Morgan and two Open Fora on Thursday evening: A Companion to Ancient Epic led by John Miles Foley (University of Missouri, Columbia) which will seek colleagues' wisdom on the compilation of A Companion to Ancient Epic, a broadly based resource of approximately 40 essays on Greek, Roman, and Near Eastern epic; and a Graduate Student Forum: How to Succeed in Classics... led by Peter Knox (University of Colorado) which will be an informal discussion of publishing, teaching, service and other professional expectations graduate students will face. And finally there will be the opening salvo of the Centennial Celebration: The CAMWS Oral History project. A video crew will be there to record your memories thoughts about the past and future of our association. If you would like to contribute, contact the CAMWS office.

# ► CAMWS TEACHING AWARDS 2001

# 1. Kraft Award for Excellence in Secondary School Teaching:

Named for CAMWS benefactress Eunice E. Kraft, this award recognizes outstanding teachers of Latin in public or private schools (middle schools included) within our area. The honoree will receive \$500, air-fare to the annual meeting at the Saturday stay-over rate, and two nights accommodation at the convention hotel. On Saturday of the meeting, the recipient will give a brief talk. Nominees must teach in the CAMWS area and will be eligible for consideration for three consecutive years.

Nominations should be accompanied by the following supporting data (not to exceed ten pages):

- Information about the school(s) in which the nominee teaches;
- Levels of Latin courses and enrollments;
- Success of students in competitions and further study;
- Information about any special courses or forms of instruction developed by the teacher;
- Testimonials from school administrators, fellow teachers and/or students.

### 2. Award For Excellence In College Teaching

The winner of this award will receive \$500. The nominee must be a member in good standing of CAMWS, teaching classical subjects full-time at a college or university. Nominations should be accompanied by such evidence of teaching excellence as :

student course evaluations or other student comments (which may include alumni comments), and

at least two letters of support from the recipient's teaching colleagues at the same or other institutions.

These letters should normally include one from the nominee's department or program chair. Other evidence of teaching excellence, such as pedagogical publications, is also welcome. Professional service may be considered as a tie-breaking factor. Nominees who have not already been recognized through a national teaching award, will regularly be given preference. No sitting member of the Subcommittee on Good Teacher Awards or of the CAMWS Executive Committee is eligible for this award.

# Manson A. Stewart Scholarships for 2002-2003

The Classical Association of the Middle West and South will award scholarships of \$1000 to a limited number of undergraduate students majoring in Classics at the sophomore or junior level at a CAMWS college or university. Nominees should be planning to take a minimum of two courses in Latin or Greek (normally at least one per quarter or semester) during the junior or senior year in which the scholarship is held.

Students are to be nominated by a department or program; no institution may nominate more than two students per year. Each nominee will be asked to fill out an application form, write a brief essay, and submit a college or university transcript and two letters of recommendation from teachers who are members of CAMWS.

The chair or other representative of the department or program should request application forms by **January 18**, **2002** (postmark date). All necessary documents for a complete dossier must be sent no later than **February 18**, **2002** (postmark date).

Results of the competition will be announced during the Business Meeting at the CAMWS meeting in April.

### MANSON A. STEWART EDUCATION AND TRAVEL AWARDS 2001-2002

The Classical Association of the Middle West and South sponsors two awards for primary-, middle-, and secondary-school teachers under the Manson A. Stewart Awards. Recipients must be members of CAMWS.

**Education Awards**: Designed to provide some financial assistance to those who wish to obtain certification to teach Latin at the primary through the secondary level, whether the specific courses are needed in Latin or in Education. The award is not intended to cover all costs of the training, and the size of the award varies according to the actual costs (primarily tuition and travel), the size of the committee's budget, and the number of applications. Previous awards have been as high as \$700. Deadline: postmarked by February 1, 2002.

**Travel Awards**: Designed specifically to assist teachers of Latin with a cash award to offset the costs of attending the annual CAMWS meeting, or the Southern Section meeting. The award is not intended to cover all costs of the travel, and the size of the award varies according to the actual costs the travel will entail, the size of the committee's budget, and the number of applications. Awards for travel to annual meetings have ranged from \$300 to \$500; for travel to the Southern Section, somewhat less. **Deadline: postmarked February 1, 2002 for the CAMWS meeting in Austin, TX**; check the on-line announcements for the Southern Section deadline or contact the chair of the committee.

### PRESIDENTIAL AWARD FOR OUTSTANDING GRADUATE STUDENT PAPER AT THE ANNUAL MEETING OF CAMWS

Each year since 1996 CAMWS has offered the Presidential Award for the Outstanding Graduate Student Paper at the Annual Meeting. Eligible are graduate students whose papers are accepted for the program and who will not have received their Ph.D. by the time it is read. The text of the oral talk is submitted at least one month in advance of the meeting, and an ad hoc committee selects the winner. The award (with a prize of \$200) is presented at the annual business meeting, even though the winner might not yet have read it by the time of that session.

There are two criteria for evaluation: (1) the quality of the scholarly argument, the originality of the treatment, and the quality of mind displayed; (2) the effectiveness for oral presentation, including the quality of the writing, good organization, and interest to an audience.

- Any graduate student whose abstract has been accepted by the Program Committee may submit a complete text for consideration for the award, along with any handout that is to accompany the oral presentation. # SEMPLE, GRANT, AND BENARIO AWARDS

The CAMWS Teaching Awards Subcommittee is pleased to announce a competition for the 2001 Semple, Grant, and Benario Awards.

The Janice and Herbert Benario Award is a \$1,500 fellowship that the recipient may apply to the summer travel program of his or her choice.

Recipients of these awards must be current members of CAMWS who either:

- currently hold teaching positions in Greek or Latin in an elementary or secondary school in the CAMWS territory; or
- are enrolled as graduate students in a degree-granting program in Classics.

# ► THE CAMWS AWARD FOR SPECIAL SERVICE

This year marks the inauguration of a new CAMWS award whose purpose is to formally acknowledge specific accomplishments that have been done "above and beyond the call of duty" for the profession and/or for the promotion of the classics in CAMWS territory. The award will be given pro re nata; some years there may not be a suitable candidate; other years there may be more than one recipient.

Eligibility: CAMWS membership is not required. Recipients can be Classicists or non-Classicists who have made special contributions to the promotion of Latin and Classical studies, especially at the state and local level in CAMWS territory. Ideal candidates are people involved in our field who do much for their local communities or classics in general, but do not interact frequently if at all at large meetings. Nevertheless, these people make MORE than a difference in their areas, state, or provinces. Suitable candidates for this award could also include parents or community members who have supported local Latin programs in very notable ways, companies that generously donate money or other resources for the promotion of Latin, school administrators who have helped Latin teachers or programs with access to school rooms or supplies or extra funds, newspapers or magazines that have given free advertising for several events, benefactors who have given money for books or scholarships or perhaps students who have promoted Latin in an original manner.

Nomination and Selection Process: Please submit by March 1st a signed statement of nomination 500-600 words

in length that describes the nominee and his/her work to the address below. Supporting documents are not required, but they may be solicited if questions arise. The chair of the Steering Committee on Awards and Scholarships with advice from the five subcommittee chairs will then determine the winners. Announcement of the results will be made at the spring meeting.

# THE BERNICE L. FOX CLASSICS WRITING CONTEST

<u>About the Contest</u>: This contest is open to any student enrolled full-time in high school during current school year. An award of **\$150.00** will be given to the author of the best entry written in English on a specified theme. The entry may be an essay, a short, story, a play, a poem, or any original literary work. This contest was established in 1985 by the Department of Classics at Monmouth College in Monmouth, Illinois, to honor Bernice L. Fox, to promote the study of Latin and the Classics in high schools, and to recognize the good work of high school students.

<u>About Bernice L. Fox</u>: Bernice L. Fox taught courses in English, Latin and Greek at Monmouth College from 1947 to 1981, and served as chair of the Department of Classics from 1970 till her retirement in 1981. Throughout her long and dynamic career she worked tirelessly to promote the Classics in Illinois high schools and colleges. She is also the author of Tela Charlottae, the Latin translation of E. B. White's *Charlotte's Web*. In 1991 Monmouth College conferred on her the honorary degree of Doctor of Humane Letters.

<u>Topic for 2002</u>: Communicate to an ancient Roman how Latin and Roman culture are important in 21st century America

<u>Judging</u>: Papers will be judged on historical accuracy, appropriate use of ancient sources, originality, quality of material, thematic development, appropriateness, correctness of English style, and effectiveness of presentation.

<u>Contest Guidelines</u>: Entries must be typed, double-spaced, on 8-1/2 x 11 inch paper, on one side only. The entry must fit the theme of this year's contest. No minimum or maximum length is required. The entrant's name and school must not appear on the entry. Contestants should use their Social Security Numbers (or a randomly selected nine character series as a personal identification code). This code must be placed on the top left-hand corner of every page of the entry and on a separate 8-1/2 x 11 inch sheet of paper which also contains the following information: author's name, date of birth, Social Security number (optional), school name, school address, teacher's name, and school phone number. No more than ten entries will be accepted from any individual school and only one entry per student. Failure to follow these guidelines will result in disqualification. Every entrant will receive a certificate of participation from Monmouth College. All entries must be postmarked no later than March 15, 2002, and mailed to Dr. Thomas J. Sienkewicz, Capron Professor of Classics, Monmouth College, Monmouth, Illinois 61462 (E-Mail: toms@monm.edu). No electronic submissions will be accepted. Papers should be 15 minutes in length, or 20 minutes for illustrated presentations. Be sure to note on the form whether you will need audiovisual equipment—computers cannot be supplied.

Organizers of panels should submit an overall description and a one-page abstract of each presentation. The names and academic affiliations of the organizers and presenters should be listed on a separate page. Especially encouraged are panels likely to be of broad interest, including those concerned with pedagogy.

Presenters must be members of CAMWS at the time of submission. Dues (\$35; \$15 for students) may be enclosed with the abstract.

# SEARCH FOR NEW SECRETARY-TREASURER

The Classical Association of the Middle West and South announces the continuation of the search for the position of Secretary-Treasurer, replacing the current Secretary-Treasurer Prof. Gregory N. Daugherty of Randolph-Macon College. The position will be officially filled in April 2004, but a successor should be named no later than April 2003, and preferably earlier. Professor Daugherty will continue to serve during the transition period.

The Secretary-Treasurer is the chief operating officer of the organization, is responsible for all financial commitments, and provides continuity in planning and policy. The Secretary-Treasurer receives travel expenses and an annual stipend determined by the Executive Committee; CAMWS also compensates a secretarial assistant and reimburses the home institution for postage, a dedicated telephone line, copying costs, supplies, and other routine operating expenses.

The successful candidate should be tenured, usually a Professor or Associate Professor in Classics or closely related discipline, with skills in business management, the ability to manage computer databases, and familiarity with the operation and membership of CAMWS. The candidate must be a CAMWS member from an institution in CAMWS territory. Previous service on the CAMWS Executive Committee is preferred. The Secretary-Treasurer will be selected by nomination of the Search Committee to the Executive Committee and the CAMWS membership, and is renewed annually by recommendation of the Executive Committee. The Search Committee consists of James Ruebel (Chair), Ball State University; Susan Martin, University of Tennessee; and John Miller, University of Virginia. The official term of office is one year, but a five-year initial commitment is normal, with renewals often extending for eight or more years. The successful candidate will need a commitment from her or his home institution of office space and release time (normally 50%).

Screening of applications began on December 1, 2001; the search will continue until and conclude when a successful candidate has been found. # PROPOSED AMENDMENT TO THE CAMWS CONSTITUTION

Winter 2002

### That the section:

Article II. Officers. Section 4. There shall be an Executive Committee consisting of the President, the President, the first Vice-President, the Secretary-Treasurer, the immediate past President, the Editor of *The Classical Journal*, the Chairs of the Finance Committee, the Committee for the Promotion of Latin, the Membership Committee, and the Steering Committee on Awards and Scholarships, and four additional persons who shall serve for terms of four years each, one term expiring each year.

There shall be an Executive Committee consisting of the President, the President-Elect, the first Vice-President, the Secretary-Treasurer, the immediate past President, the <u>Editors of *The Classical Journal* and the *CAMWS* <u>Newsletter</u>, the Chairs of the <u>Development Committee</u>, the Finance Committee, the Committee for the Promotion of Latin, the Membership Committee, and the Steering Committee on Awards and Scholarships, and four additional persons who shall serve for terms of four years each, one term expiring each year.</u>

### **IN MEMORIAM**

Charles Donald Perry ("Don"), long time Classics professor at the University of Alabama, passed away at a nursing home in Buffalo, N.Y. on June 21, 2001. A bronze statue of Hermes the Psychopompos stood at his bedside at the end of his life. He was 93. During his tenure at UA, from 1950 to his retirement in 1978, Don Perry inspired countless students, including future Hall-of-Famer Joe Namath. The two struck up a friendship with one another, Namath gaining an interest in Greek sports and Perry becoming a fan of Alabama football. In the late 1970's Don Perry gained a degree of notoriety within the state of Alabama when he produced a 16-hour documentary on mythology for Alabama Public Television. Mythology was his passion always. Not only did the documentary earn him several educational awards (Perry was in the process of donating the tapes to UA's Hoole Special Collections when he died), but his mythology courses at UA were extremely popular and gave a certain vitality to the program. After his retirement in 1978, Don Perry continue to serve the cause of Latin in the state of Alabama. Along with his brother, he endowed a scholarship in his name for incoming freshmen who want to study Classics at UA. There is also an annual award in his name given to the best high school Latin teacher in the state. Then, before he moved to Buffalo to spend his final days, he donated his entire Classics library to the Department of Modern Languages and Classics at UA, which is now housed in the department's seminar room.

Students and friends remember Don Perry as good humored and caring, devoted to his church and community, with which he shared his talents as a poet, pianist, and singer. He was never married.

# SUMMER 2002: UNIVERSITY OF TEXAS AT AUSTIN CLASSES AND DESCRIPTION:

The University of Texas at Austin Summer Program features a wide selection of Classical Civilization classes, a renowned intensive Ancient Greek course, lower-division Latin, and a special three-week course for Latin teachers.

First Summer Session runs from June 5 - July 12, 2002 Second Summer Session runs from July 15 - August 19, 2002 Whole Summer Session (for Intensive Greek) runs from June 5 - August 19, 2002.

### CLASSES:

**READING LATIN FOR FUN: The UT-Austin Department of** Classics will offer a three-week course for Latin teachers (as well Classics will offer a three-week course for Lain teachers (as Well as advanced undergraduate and graduate students) in the Summer of 2002. This year's class will be "The Art of Latin: Reading Latin For Fun," taught by William Nethercut. The class will meet June 10-28, Monday through Friday, 8:30 -11:30 a.m. Rather than focusing on a single author, period, or literary genre, we shall read over the whole range of Latin authors, from Ennius and Pacuvius to Claudian and Lactantius, and then onward to the Renaissance in poetry and from Cato the Elder Caecar

to the Renaissance in poetry, and from Cato the Elder, Caesar, Cicero, on to Jordanes on Attila the Hun, and Medieval and later prose authors. Texts and critical notes will be provided by the instructor; the purchase of new texts will not be necessary. Grading: Each class member will prepare instructional materials, or a unit for teaching others how to approach Latin with a fuller appreciation. There will be no final exam.

INTENSIVE GREEK: An accelerated course for highly motivated students. Students of diverse backgrounds and interests will develop a keen understanding of the structure of the Greek language and a love of Greek prose and poetry. No previous knowledge of Greek necessary. If you have had a year or two, the special approach in this course will deepen your grasp of how Greek works and why it is so subtle a vehicle for conveying ideas. The class will meet June 5 - August 19, Monday through Friday, 8:30-11:00 a.m. and 12:00-2:30 p.m. First half will be taught by Tom Palaima, second half by Erwin Cook.

Admission and Registration: Telephone Summer Session registration is June 3 - June 4 and classes begin June 5. Participants in the Classics program not previously enrolled in the University must apply in advance to: Office of Admissions, The University of Texas, Austin, TX 78712, phone (512) 475-7399. The deadline for completing applications for summer admission is May 1, if you have not previously attended UT-Austin and do not seek a degree here. In this case you may be admitted as a Summer Transient Student - do make that clear when you apply for admission.

#### SUMMER INSTITUTES FOR LANGUAGE EDUCATORS 2002

#### **Action Research in Foreign Language Education**

Institute Leader: Dr. Richard Donato Dates: June 27-July 3, 2002 Application Deadline: April 30

Description: Understanding how we teach, how students learn, and how we can best assist this learning in our own local teaching situations is the purpose of the Action Research Institute. Experienced and practicing K-12 foreign language teachers and teacher educators at institutions of higher education who prepare K-12 foreign language pre-service and in-service teachers will explore the uses and benefits of classroom-based inquiry for improving and changing foreign language instruction; examine the nature of action research and the tools of inquiry that are typically used in action research; develop their own action plans to be carried out during the school year, select appropriate tools of inquiry, and collect and analyze information; and establish an action research network for support and guidance during their classroom-based investigations.

#### K-8 Arabic, Chinese, Hebrew, and Japanese: Teacher Preparation

**Description:** This institute will enhance the skills of teacher educators who prepare pre-service and in-service teachers and grade K-8 Arabic, Chinese, Hebrew, and Japanese teachers. Topics to be addressed in the institute include: the growth and development of the K-8 child, K-8 curriculum, effective K-8 classroom teaching strategies, development of literacy in character-based languages, standards in foreign language education, authentic assessment and national trends. Participants will observe a daily Japanese demonstration class for young children taught by Japanese teacher, Jessica Haxhi. Language specialists will lead intensive language immersion sessions in which participants will reflect on the concepts addressed for the language they teach and will design lessons to be shared in a national database.

#### Integrating Technologies in the Foreign Language Classroom Institute Leaders: Karen Willetts, Cindy Kendall, and Dr. Carine

Application Deadline: April 30

**Description:** This institute will include two interacting strands for K-12 foreign language teachers and teacher educators that are designed to enhance effective technology-based instructional practices in K-12 foreign language classrooms. In this institute participants will enhance their skills with hardware applications such as color-scanners, digital cameras, CD-ROM drives, multimedia stations, storage solutions and presentation tools as well as build skills in telecommunications, the Internet and distance education. They will learn to design effective Web pages, examine and evaluate the newest equipment and most recent developments in educational technologies, and reflect on instructional trends in a high-tech distance learning classroom. Teacher educators will learn to integrate technology into the strategies and content pre-service teachers will use with K-12 foreign language students.
