Second Call for Papers

Members of CAMWS are invited once again to submit abstracts for papers to be considered for presentation at our annual meeting in Iowa City, Iowa. Four copies of the abstract should be submitted, typed, on no more than a single sheet of paper. The author's name and address should appear only on a cover sheet. Indicate whether the talk is illustrated. Normal length is 15 minutes, 20 for illustrated papers. CAMWS FUNDING SOURCES

Manson A. Stewart Educational Assistance Scholarships are available to provide assistance to aid those who are seeking to become certified Latin teachers. Several awards are granted each year for assistance with tuition for certification purposes for Latin teachers. The committee also distributes awards designed to enable attendance at CAMWS meetings to provide for staying current in the profession. The application deadline is March 15 for funding desired during the summer or fall and November 15 for funding desired during the spring semester. The application deadline is October 15 for those desiring funds to facilitate attendance at the meeting of CAMWS' Southern Section (see the invitation below) and February 1 for those who wish to attend the annual meeting of CAMWS itself. Awards for Summer Study Abroad The Awards Subcommittee of CAMWS announces competition for (1) the \$2,500 Mary A. Grant Award to the 1993 Summer Session of the American Academy of Rome; (2) the \$2,500 Semple Award to the 1993 Summer Session of The American School of Classical Studies at Athens; (3) a \$1,500 award for summer study in either Greece or Italy. This third award may be used for the summer session of the American Academy or the American School or any other study program in Greece or Italy. Any elementary or secondary school teacher or graduate students in the CAMWS area and who is a member of CAMWS is eligible to apply for one of these awards for study abroad in the summer of 1993. The forms for this year's competition will be available beginning September 15. For application forms please write Kathryn Thomas at the address located on the last page of this newsletter. Requests for forms must be received by January 15, 1993 and completed applications are due February 2, 1993. Each year we send some of our many deserving and highly qualified members overseas. Why shouldn't it be you? For more information, write to Kathryn Thomas, chair of the committee.

CAMWS College Awards. Finally, for your students, remember that up to 7 awards will be made to any junior or senior in his/her final year of high-school Latin during 1992-3 and whose teacher is a current CAMWS member can compete. The award consists of a scholarship of \$500 and membership in CAMWS for the 1993-1994 college year. Recipients agree to continue to work in Greek or Latin for at least one year at the college or university of their choice. The recipients are selected on the basis of performance in a competitive examination to be set and graded by the CAMWS college Awards Committee. The examination will be comprised of unseen passages of Latin prose and poetry and will be administered during early February by proctors at individual participating schools. An entry form appears on the opposite page. Merely fill it out and return it with an entry fee of \$2.00 per student intending to take the exam (checks made out to CAMWS) and mail it to Rob Ulery, whose address is opposite. All checks and forms are due by December 15, 1992 along with the application form on the opposite page. Best of luck! We have some excellent students and programs in the CAMWS area. Let them shine!

CLASSICAL ASSOCIATION OF THE MIDDLE WEST AND SOUTH COLLEGE AWARDS

Application Form

There will be up to 7 \$500 awards and memberships in CAMWS for the 1993-1994 college year.

Deadline: December 15, 1992

Any junior or senior taking his/her final year of high-school Latin in 1992-1993 school year from a secondary school in the 31 states and 3 provinces of CAMWS, whose teacher is a member of CAMWS (membership information can be found on the inside back cover of CI), and who will continue to work in Greek or Latin for at least one year at any college or university, is eligible to compete for the awards.

There will be one examination consisting of a passage of Latin prose and of poetry, both for sight translation. The examination is intended primarily for students who have had three or fours years of Latin, but superior second-year Latin students may also enter the competition.

The examination must be administered by a school official other than the Latin teacher during the week of February 1-5, 1993.

OTHER PEOPLE'S MONEY

There are many fine sources for funding for a wide variety of worthwhile activities, and each year many CAMWS members win many awards and grants. Consider the following.

- The Stanford Humanities Center will offer up to six external fellowships for 1993-94 in the following categories: (1) senior fellowships for well-established scholars (2) junior fellowships for scholars who at the time of application are at least three years beyond receipt of the Ph.D. and normally no more than ten. For 1992-93, junior fellows were offered stipends of up to \$20,000 and senior fellows stipends of up to \$30,000. The deadline for application is November 16, 1992. Application materials and further information may be obtained by writing to the Fellowship Program, Stanford Humanities Center, Mariposa House, Stanford University, Stanford, CA 94305-8630.
- The National Humanities Center offers 35-40 residential fellowships for advanced study in history, philosophy, languages and literature, classics, religion, history of the arts, and other fields in the liberal arts. The Center awards fellowships to senior scholars of recognized accomplishment and to promising young scholars. Fellowship stipends are individually determined in accordance with the needs of each Fellow and the Center's ability to meet them. Application deadline for the academic year 1993-94 is October 15, 1992. For application material write to: Fellowship Program, National Humanities Center, P.O. Box 12256, Research Triangle Park, NY 27709-2256.
- The National Endowment for the Humanities Summer Fellowships for Foreign Language Teachers K-12, offer stipends of \$3,750 for six weeks study abroad. You must have three years full-time paid teaching prior to the fellowship summer with at least one-half of the schedule teaching foreign languages, must be employed by a U.S. school or U.S. school abroad, must demonstrate an intention to teach foreign languages at least five more years, and must agree not to accept another full-support grant during the fellowship period. The application deadline for summer of 1993 is October 31, 1992.

- The NEH also announces its Summer Stipends, which provide support for faculty members in universities and two-year and four-year colleges, and for other persons working in the humanities, so that they can devote two consecutive months of full-time study and research to their projects. An applicant's project may be one that can be completed during the stipend period, or it may be part of a long-range endeavor. Each institution of higher education may nominate three of its faculty for the Summer Stipends competition. Scholars not affiliated with educational institutions may apply directly to the program. - The Fulbright Teacher Exchange Program announces its annual call for applications from U.S. university and college faculty, secondary and elementary school educators interested in teaching abroad during the 1993-94 academic year. Applications must be received by October 15, 1992. - Mellon Postdoctoral fellowships at Stanford are also announced. Applications are currently available and completed applications are due no later than November 18. STUDENT SCHOLARSHIPS AND AWARDS

Graduating seniors at high schools across the nation, who are interested in pursuing majors in Classics (Greek and Latin) or in Latin and Classical Humanities at The Catholic University of America, are invited to compete for undergraduate scholarships and grants available to incoming freshmen, including the Martin Rawson Patrick McGuire Scholarships, which are awarded only to CUA freshmen seeking to become majors in the Department of Greek and Latin. Currently, a full scholarship may remit more than \$46,000 in tuition expenses. Latin teachers with students eligible to compete for McGuire Scholarships are asked to contact the Department of Greek and Latin at CUA (202/319-5216) no later than October 4, 1991.

TRAVEL OPPORTUNITIES

Vita Antiqua, a residential study semester will be available in second semester only, i.e., from February 1 until June 11, 1993. As well as following classes in Latin, Roman topography, and classical studies, students will make special trips (at least four) to such places as Pompeii, Herculaneum, Hadrian's Villa (Tivoli), Ostia Antica, and Tarquinia. In addition, students will take part in the School's regular trip program (e.g. Venice, Palermo, Florence, Orvieto, Siena or Trieste.) Students will be able to follow a regular American high school program (including most Advanced Placement programs). 
