

LOCAL LODGING AND TRAVEL

The Atlanta American is located in downtown Atlanta, directly across the street from the Greyhound and Trailways Bus Terminals. The airport buses include the American on their tour of hotels; be certain that you board a bus going downtown and inform the driver of your destination. Amtrak serves Atlanta with two trains daily. Brookwood Station is located on Peachtree Street about four miles north of the hotel. The easiest means of surface transportation to the hotel is by taxi; almost as convenient, and much cheaper, is one of numerous MARTA buses going south. Exact fare of 60 cents is required. Exit the bus in front of Davison's Department Store and walk two blocks west to the hotel.

The convention rates are \$45 per night single, \$57 per night, double.
