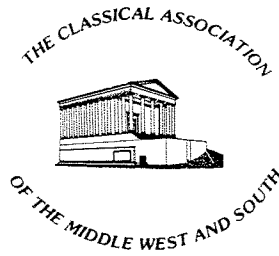

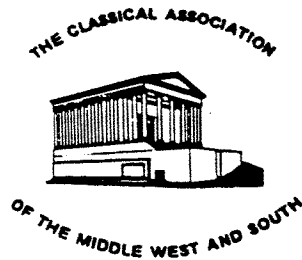
Those of you who attended last year's meeting in Columbia are aware that several CAMWS members have raised the issue of socially responsible investing of CAMWS funds. A petition was circulated which gathered 68 signatures and which stated, in part, that, "We think that it is important for our money to be invested in companies and financial instruments which exploit neither the environment nor oppressive political and economic conditions".

I propose through this note both to inform you of developments along these lines and to solicit your opinion in this matter. This is a very serious question and it affects everyone who pays dues since the main use for the profits made on our investments goes to finance our scholarship and awards programs. I would therefore like to have the executive and finance committees formulate a policy based on as broad a sense of the membership's feeling as possible.

So could I ask you to take the few minutes required to fill out the two question form below and to mail it to Prof. John Hall, Secretary Treasurer, CAMWS 118 KMB, Brigham Young University, Provo UT 84602? Your responses will be carefully weighed at the next executive committee meeting in Baton Rouge in conjunction with the Southern Section meeting. Therefore, please reply before October 15.

Please respond, even if your choice is "Don't Know". We need as broad a response as possible. Thank you.

SECOND CALL FOR PAPERS

Abstracts are hereby solicited from members of The Classical Association of the Middle West and South who wish to present papers at the Association's 87th annual meeting in to be held April 3-6, 1991 in Hamilton, Ontario in conjunction with McMaster University. Abstracts should be neatly and legibly typed -- single space -- on no more than a single sheet of paper. Please note this new request on space which is prompted by a need to curtail the spiraling cost of the abstracts book. The author's name and affiliation should appear only on a separate cover sheet. Please indicate the amount of time the delivery will take (normal maximum of 15 minutes, 20 minutes for illustrated talks). Due to the increasing volume of proposals, incomplete or improperly prepared proposals will be regretfully returned to their authors.

Panel proposals are also encouraged, but they must include abstracts of the individual papers for each panel. Since McMaster has a fine study collection of coins a numismatic panel might be in order and, of course, panels dealing with methodology and issues pertaining to elementary and secondary teaching of Latin are always welcome. Increased demand for space on the program has necessitated a limit to the number of panels which can be accepted.

The Awards Committee of the Classical Association of the Middle West and South announces the competition for: (1) the \$2,500.00 Mary A. Grant Award to the 1991 Summer Session of the American Academy of Rome; (2) the \$2,500.00 Semple Award to the 1991 Summer Session of the American School of Classical Studies at Athens; (3) a \$2,500.00 award for summer study in either Greece or Italy. This third award may be used for the summer session of the American Academy or the American School or any other study program in Greece or Italy.

Any elementary or secondary school teacher or graduate student in CAMWS's 30 states and three provinces of Canada, who is also a member of CAMWS, is eligible to apply for one of these three awards to study abroad in the summer of 1991. The forms for this year's competition will be available beginning September 15.

College Awards 1991

Up to 10 awards and memberships in CAMWS for the 1991-92 college year will be awarded to students who best translate unseen passages of Latin prose and poetry. Any junior or senior enrolled in his/her final year of high school Latin during the 1988-89 school year, and from a secondary school in the 30 states and 2 Canadian provinces of CAMWS, whose teacher is a current member of CAMWS, is eligible to compete. The amount of the scholarship award is \$500.00. A further stipulation of the award is that its holders continue work in Greek or Latin for at least one year at the college or university of their choice.

Award recipients will be selected on the basis of performance in a competitive examination to be set and graded by the CAMWS College Awards Committee. The examination will be comprised of unseen passages of Latin prose and poetry. Examinations will be administered during early February by proctors at individual participating schools.

Any teacher with students wishing to compete in the 1991 College Awards should fill in the entry form found on the back of this announcement, before **December 15, 1990** and return the completed application with an entry fee of \$1.00 per student intending to take the examination. Checks should be made out to CAMWS. All application forms and fees must be received no later than **December 15, 1990**. Please note this year's procedural change. You do not need to request entry forms. The only necessary application is on the back of this advertisement. There will be up to 10 \$500 awards and memberships in CAMWS for the 1991-1992 college year.

Any junior or senior taking his/her final year of high-school Latin in 1990 from a secondary school in the 30 states and 2 provinces of CAMWS, whose teacher is a member of CAMWS (membership information can be found on the inside back cover of *CJ*), and who will continue to work in Greek or Latin for at least one year at any college or university, is eligible to compete for the awards.

There will be one examination consisting of a passage of Latin prose and of poetry, both for sight translation. The examination is intended primarily for students who have had three or four years of Latin, but superior second-year Latin students may also enter the competition.

The examination must be administered by a school official other than the Latin teacher during the week of February 4-8, 1991
